## **WHAT DID YOU DO AFTER THE PATROL:**

### **1. Floyd Branchfield -Retirement Bio**

After my retirement from the Wisconsin State Patrol I pursued a Bachelor of Science degree in nursing from the University of Wisconsin-Oshkosh. The vast number, and serious extent of injuries I experienced on the road as a State Trooper, directly influenced my pursuit of a career in nursing.

While enrolled in the four year College of Nursing program, I worked evenings for the University of Wisconsin-Oshkosh police department as a “police radio dispatcher.” Additionally, during one summer free of educational pursuits, I obtained my private pilot’s license through enrollment at Sentry Aviation flight school in Stevens Point.

Following graduation from the University of Wisconsin-Oshkosh, College of Nursing, I was offered and accepted a Psychiatric nursing position on the forensic admissions unit at Winnebago Mental Health Institute, north of Oshkosh. Coincidentally, I began my second career working for the State of Wisconsin. After working a number of years in mental health nursing I accepted a lateral transfer to the Oshkosh Correctional Institute, a medium security prison in Oshkosh, Wisconsin. There I joined the Correctional health team in providing health services to the inmates incarcerated at that facility.

After working for the Department of Corrections for a number of years, I promoted to a supervisory position as Health Service Unit Manager at Fox Lake Correctional Institute, a medium security prison near Waupun, Wisconsin. While supervising the Fox Lake unit I was asked by the State Correctional Health Office to also provide temporary supervision to the Health Service Unit at the maximum security Green Bay Correctional Institute.

I accepted the challenge of supervising two correctional health service units simultaneously. Over a six month period I divided my supervisory responsibilities between Fox Lake and Green Bay Correctional Institutes. During that period of time I also instituted a new policy and procedure at both institutes to cross train all of the nurses to provide health services to the minimum security correctional camps affiliated with each prison.

Following a rewarding career in correctional health I returned to the Winnebago Mental Health Institute to create and operate an Employee Health Clinic. Within two weeks of my hire date the Employee Health Clinic was open and fully functional. At a later date, I was joined in the Health Clinic by a licensed physician. As a team, the physician and I performed new employee physicals, provided emergency care for patient induced staff injuries, conducted annual tuberculosis screenings on all employees, administered annual employee influenza vaccine, and more.

While Employee Health Nurse I was also responsible for administering the hospital's Infection Control program. This included coordinating an internal infection control team as well as collaborating with and supporting our sister facility, Mendota Mental Health Institute in

Madison. I'm proud to state that in the number of years I held the role of infection control practitioner, WMHI passed every periodic Joint Commission infection control survey with flying colors.

Throughout the years I operated the WMHI Employee Health Clinic, each semester I provided an on-site clinical experience for 35 UW-Oshkosh nursing students. I supervised students as they provided immunizations, gave TB skin tests, drew blood and performed other clinical nursing skills.

I formally retired from State service in 2001 and was hired by Wisconsin Physician's Services (WPS) in Madison, Wisconsin. In that role I managed the process of screening physician billing practices for Medicare Part B in the states of Wisconsin, Michigan, Minnesota and Illinois. I managed a team of 35 RNs, four nursing supervisors, three Program Assistants and a social worker.

I retired from my executive position at WPS in 2007. In 2015 my wife, Jane, retired from a 32 year career with the State of Wisconsin, at which time we moved to Hawaii Island where we now enjoy our retirement years.

2. After retiring from the WSP I enjoyed retirement for several months before going back to work. I went back to work at Badger Bus lines as a training coordinator. And my other responsibility was to drive the big yellow school bus. That came to an abrupt end due to COVID. So it was back to enjoying retirement. Kim Hurley

**JEFFERSON COUNTY, Wis.** - Jefferson County District Attorney Monica Hall announced on Tuesday, Feb. 16 that the actions of law enforcement officers resulting in the death of Joseph Crawford-Lamal on Dec. 9, 2020 were lawful and reasonable acts of self-defense. Therefore, there will be no criminal charges in relation to the incident.

According to the DOJ, at approximately 12:30 p.m. on Dec. 9, Wisconsin State Patrol attempted a traffic stop for speeding on Highway 26 between Watertown and Johnson Creek. One driver and one passenger were inside the vehicle. The vehicle stopped for a short time, and the only passenger fled the vehicle, then the vehicle fled the scene. The passenger was later apprehended.

Wisconsin State Patrol pursued the vehicle. While pursuing, the individual inside the car fired shots from the vehicle at law enforcement. The vehicle continued southbound on Highway 26, road spikes were deployed, and the vehicle struck them. The vehicle exited Highway 26 at Highway 12 and came to a stop in the median. The driver exited the vehicle with a handgun and attempted to carjack a civilian, according to the DOJ. Three Wisconsin State Patrol Troopers then discharged their weapons and struck the subject. Law enforcement began life-saving measures on the driver. However, the driver, Joseph Crawford-Lamal, died of multiple gunshot wounds at the scene.

DCI led this investigation and was assisted by Jefferson County Sheriff's Office, Wisconsin State Crime Laboratory, and the DOJ Office of Crime Victim Services.

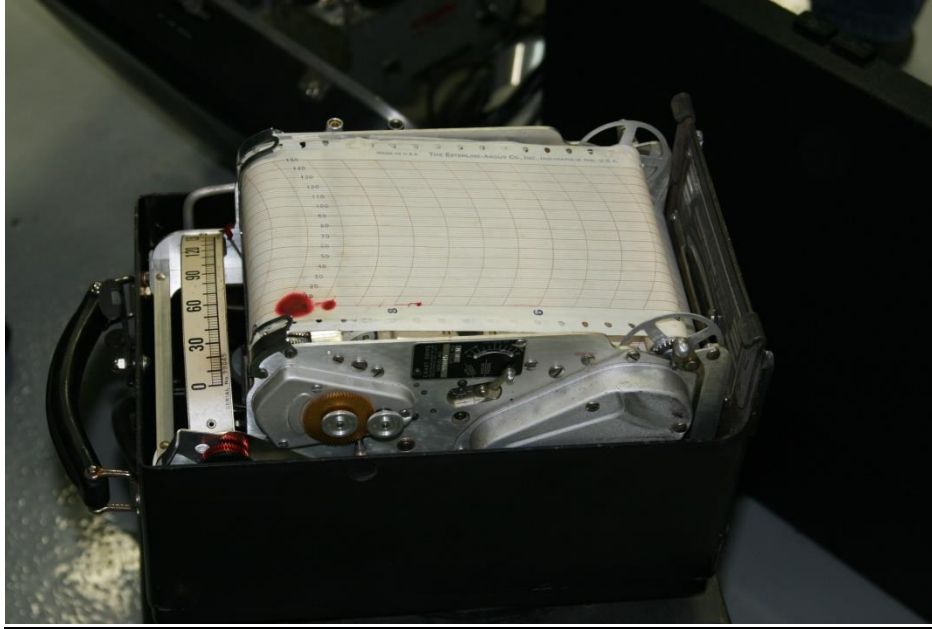
